### 5. NEW BUSINESS

- a. HOMELESSNESS IN OUR COMMUNITY
  - i. OUTREACH AND CONTACTS

-March 6<sup>th</sup> Homeless Connect Event in St Cloud w/transportation provided from Sauk Centre **MSP** Laurie Ostwald/ChristineLandherr to have a booth at the event and to cover the cost of \$25.00 from the **Public Awareness and Child Find Resource Fair Registration Fees.** -Makayla will staff the booth.

-Alicia's Homeless Coordinator will have update at next meeting

- b. UPDATES FROM PUBLIC AWARENESS COORDINATOR/ACTIVITIES- MAKAYLA
  - i. Help Me Grow Website
  - ii. Community Resource List
  - iii. Outreach Updates on purchases, etc.

-Makayla provided information on the work she has been doing. She has connected in some way with the clinics in each county offering information and resources as well as offering to come and speak with them about HMG. She has been asked to present at Avon/Albany and Melrose so far.

-Makayla will forward a list of contacts and responses she has had with the clinics so that IEIC members can provide input/support based on the connections they already have in this area. -It was noted that WIC is part of Public Health in Benton, Sherburne, and Stearns Counties. In Wright County WIC is provided by Wright County Community Action.

-Makayla showed pictures of the promotional items that have been ordered but are not yet available for distribution.

-A discussion about billboards noted that while they look nice, the contact information is very small and not easy to read. It was noted that if we do them again we will be sure that the font size is increased. Also, the location of the one noted as Sauk Centre is actually pass the Sauk Centre exit and therefore is not in a good location to repurchase.

c. EHDI UPDATES/SURVEY INFO (EDUCATION COORDINATORS)

New legislation that requires follow ups is still in the process of being defined so there will be more to come in this area. It was noted that the use of an OAE to do the screening will be required. It will be up to school districts to determine who will do the screening. Members talked about who currently has the equipment needed. **We will revisit this in May** when more information is available including whether or not the IEIC can help with the purchase of the equipment.

e. EARLY CHILDHOOD SCREENING OUTREACH METHODS

-It was mentioned that having information on facebook was a good option to connect with young parents.

-There was discussion that messages about why ECS is important need to be clearer so that parents (and others) understand why they should bring their children

## 6. AGENCY NEWS AND UPDATES

-Marcia shared a flyer for an event on January 29, 2014 for working with Interpreters in Special Education (*attached*)

-**MSP** Maura O'Connor/Laurie Ostwald to pay ½ the cost of registration (\$20 for the \$40 four-hour class) up to a total of \$2000 for the Intro to Children with Special Needs classes that are being offered in each county from January-June through Child Care Aware, West/Central. This will come from **Public Awareness and Child Find Training Events**.

-Marcia & Makayla will work with Child Care Aware, West/Central to get make this happen and Child Care Aware, West/Central will invoice 7W IEIC after all classes have been held.
