



ASSESSMENT PRACTICES and RECOMMENDATIONS Part B (Age 3 to 21)

Background:

The chart below is intended to describe WCED general practices for SpEd assessments across our member districts. Please note that there may be reasons based on student/family/district circumstances that our practice may vary from what is described in the chart. It is intended to be a guideline for our process and will be updated as needed when we have new information or rulings that impact procedures. Speech, Fine and Gross Motor, Sensory, Hearing, Health Status and Early Childhood are not addressed on this chart; these areas would be administered/scored/interpreted and written up by specialists in each area. Assessments in **BOLD** are the most commonly used.

****Observations Required for Special Education Evaluations:**

Disability Area	Observations & requirements needed for eval based on criteria:
ASD	2 in two different settings on 2 different days
DCD	at least 2; with a focus on 1) adaptive behavior and 2) consideration for culturally relevant info, medical and education history
DD (age 3 to 6)	1 systematic observation in the child's daily routine setting by appropriate professional
EBD	3 in classroom or other learning environments
SLD	1 or 2 depending on subject areas of concern; may be completed during pre referral OR after permission has been obtained*

PI	2 at least one by licensed OH/PI
OHD	1 or more, by licensed special ed teacher
TBI	Not required, but at least 1 systematic behavioral observation <u>may</u> be used to document functional impairment

ORDERING ASSESSMENTS/PROTOCOLS:

1. WCED will order and purchase assessments and protocols used exclusively by School Psychs. Example: WISC - V.
2. Districts will order and purchase all other assessments and protocols administered, these costs may be reimbursed by WCED as determined on a yearly basis and communicated to Superintendents and Business Managers by WCED Executive Director.
3. In the event that a new edition of a commonly used assessment, such as the WJ IV, becomes available and needs to be updated in all districts, WCED will coordinate this purchase and may fund the expense for districts.
4. School Psychs will be responsible for coordinating the inventory, storage and ordering of all assessments and protocols at the district level.
